Regulation (EC) 1907/2006 (REACH) (SVHC):

With regard to your inquiry, we comment as follows:

Regulation (EC) No. 1907/2006 (REACH Regulation) is the EU regulation on the registration, evaluation and authorization of chemicals. It regulates the handling of chemical substances in preparations and articles.

Registration of chemical substances

The company Sibalco AG is a downstream user in the context of REACH. Our products are considered as articles (Art. 3, Pt. 1 to 3 of the REACH regulation) and not as substances. Therefore, they are not subject to registration. The base materials used are either not subject to registration or are registered by our suppliers. This applies to all distribution products as well as to our own products under the brand names Sibalco, Sloan, Inducoil and x-Mont.

No chemical substances are released from our products under normal conditions of use (Art. 7, Pt. 1 + 2 of the REACH Regulation).

Exceptions to this are: Cleaning agents and fluxes (for soldering processes).

As a so-called downstream user (Art. 3. Pt 13), we cannot provide further, detailed information on the chemical composition of these products, as we have no knowledge of their compositions.

Substances of very high concern (SVHC) according to article 33 of the REACH regulation Candidate list of 5th of November 2025

According to our current knowledge, our products contain the substances of very high concern (SVHC) listed in Table 1, which are included in the candidate list of the European Chemicals Agency ECHA.

We comply with the obligation according to Article 33 of the REACH Regulation and inform our customers immediately if, according to new knowledge, further substances which are subject to notification are contained in our products.

Furthermore, according to our current knowledge, we are not aware of or have not been notified of any other substances that are included in the updated list (SVHC) published by the European Chemicals Agency (ECHA) or that would exceed the maximum permissible concentrations.

In particular, we are not aware of any substances in our products that are listed in Annex XIV (Authorization List) and Annex XVII (Restriction List) of REACH Regulation 1907/2006.
