**Statement on RoHS Directive 2011/65/EU and Supplement 2015/863/EU**

We hereby confirm the conformity of the products supplied with Directive 2011/65/EU (RoHS II) and its amendment (EU) 2015/863 (Delegated Directive). This applies to all distribution products as well as to our own products under the brand names Sibalco, Sloan, Inducoil and x-Mont.

According to our current knowledge, we are not aware of or have not been notified of any substances according to ANNEX II of the Directive which are contained in the products distributed by us, or which exceed the maximum permissible concentrations (exception lead, see annex).

The prohibited substances and their limit values are:

The RoHS conformity, which we show on our delivery documents, is based on the information provided by the respective manufacturers of the individual products.

We also refer to their original data sheets, publications and statements.

### **Annex (Lead, Pb)**

Of the above prohibited substances, lead (Pb) can be used as an alloying component in

- Steel (e.g. 11SMnPB30)
- Brass (e.g. CuZn39Pb3)
- Aluminum (e.g. AlCuBiPb)

and may be present in higher concentrations such as 0.1%:

However, the alloys comply with the exemptions according to Directive 2011/65/EU (RoHS) Annex III Pt. 6a, 6b, 6c, 7a.
